Section 3.01. Appointment; qualifications; compensation. The council shall appoint a town manager for an ~~indefinite term and fix the compensation~~ a definite term and shall enter into an employment contract with the manager. The manager shall be appointed solely on the basis of executive and administrative qualifications. The manager need not be a resident of the town or state at the time of appointment but must reside in the town while in office.

Section 3.02. Removal or suspension of Town Manager. The Town Manager may be removed or suspended ~~for cause by majority vote of the town council in accordance with the procedures set out in 30 MRSA ss.2313 as it may be amended from time to time~~ in accordance with the provisions of the Town Manager's employment contract.

Section 5.01. Fiscal year. The fiscal year of the town shall begin on the first day of ~~January~~ July and end on the last day of ~~December~~ June.

Section 5.02. Submission of budget and budget message. On or before the fifteenth day of ~~November~~ May of each year, the manager shall submit to the council a budget for the ensuing fiscal year and an accompanying message.

Section 5.06. Capital program. (a) Submission to the council. The manager shall prepare and submit to the Council a 5-year capital program on or before the fifteenth day of ~~November~~ May each year.
